The 30<sup>th</sup> Research - Extension linkage meeting of KVK, Jagatsinghpur was held on 18.07.2019 at 3 PM in the Training hall of KVK under the Chairmanship of Dr. Biswa Ranjan Pattanaik, Senior Scientist & Head, KVK, Jagatsinghpur. The meeting was attended by The DDA-Jagatsinghpur, The DAO-Tirtol, The ADH-Jagatsinghpur, and progressive farmers from different blocks of the district.

Dr. Biswa Ranjan Pattanaik, Sr. Scientist & Head, KVK, Jagatsinghpur at the outset welcomed all officials of the line departments for their august presence. He presented the proceedings of the previous meeting and action taken report of KVK. He proposed changing of adopted villages like Bagoi and Nagapura and suggested the gathering to propose new villages in Kujanga and Tirtol block. Farmer representative Mr. Nrusingha Charan Behera, DAO-Tirtol and ADH-Jagatsinghpur proposed Balikani village of Kujanga block. DAO-Tirtol and BVO-Tirtol proposed Dainlo village of Tirtol block.

All scientists appraised the gathering of their Action Plan-2019-20 of their respective disciplines.

ADH-Jagatsinghpur proposed that while conducting OFT on planting materials production, the beneficiaries may be informed about the poly house scheme of Govt. Department and the programme can be taken in convergence mode. He suggested that KVK adopted villages should have subsidy schemes/enterprises of line departments. He appraised that Horticulture department is going for 100 ha cashew, 10 ha coconut and 60 ha mango demonstration under RKVY this year. Under Mission Shakti, the dept. is going to train women SHG in mushroom and vegetable cultivation.

Engineer from Irrigation dept. informed that water has been released in Machhagaon and Taladanda canal and it will reach the lower ends by 20<sup>th</sup> July. DAO-Tirtol suggested to prepone the date of release of water to 1<sup>st</sup> July for the better survival of rice nursery in case of monsoon failure. This view was agreed upon by farmers.

Scientist(Soil Science) and DDA discussed on the possibility of conducting Awareness camp for better interpretation of soil health cards.

Mr. S. K. Pani, farmer suggested introducing new varieties of Rice through farmers clubs. BVO-Tirtol said that dept. is going for demonstrations under backyard poultry scheme in Lankapada and Kanakpur area of Tirtol. KVK may converse with the programme.

Mr. Nrusingha Charan Behera, Farmer representative suggested to include CADA officials in R-E linkage meeting for better coordination between CADA and irrigation dept. He requested to the DDA-Jagatsinghpur for timely availability of fertilizers and pesticides.

DDA said that the dept. is going to undertake seed treatment campaigns, training on management of Fall Army worm, Safe use of pesticides in each block. He informed that the last date for PMFBY registration is 31<sup>st</sup> July for non-loanee farmers.

DAO-Tirtol suggested to conduct awareness camp on cutworms.

The meeting was ended with vote of thanks by Mrs. S. Das, PA(Fishery).
